We are proud to announce that on Saturday, June 10, 2023, the Grand Prix Tom Dumoulin will be held for the 1st time in our existence.

A unique concept of, on the one hand, a tough climbing competition at the Tom Dumoulin Bike Park in Sittard-Geleen, after which a team time trial will be held in and around the village center of Buchten.

Both the Board of the Bike Park Foundation Sittard-Geleen and the cycling committee Buchten welcome 22 junior teams, each with 6 riders. An international field that will compete for the highest honours.







Regulations

The Grand Prix Tom Dumoulin

Article 1

The Grand Prix Tom Dumoulin, hereinafter referred to as "the competition", is organized on Saturday 10 June by the Bike Park Sittard-Geleen Foundation and Cycling Committee Buchten and holds the competition license from the KNWU and the permits and exemptions from governments. These are available for inspection at the secretary of the organization

Article 2

This race over 70 km (route 1) and 18 km (route 2) is open to teams of 6 riders in the junior category

Article 3

The participants are expected to be aware of the regulations, provisions and instructions of the KNWU and organization, and are expected to know both routes.

Article 4

The Grand Prix Tom Dumoulin is open to riders from the junior men category and is ridden according to the regulations of the KNWU. Therefore, the resistance is 7.93 meters

Article 5

In the permanence (Bike park Sittard-Geleen and indicated by a Permanence sign) the back numbers and frame plates are handed out against the surrender of a valid license. The control of supervisors' licenses will also take place here.

The back numbers do not have to be returned. The frames must be returned. The licenses can be picked up after the game in the permanence party tent in Buchten (Dorpsstraat).

For foreign teams, transponders can also be picked up at the permanence. These transponders must be handed in after the race at the permanence in Buchten (party tent Dorpsstraat Buchten).

Article 6

Washing and changing facilities are located at the Tom Dumoulin Bike Park. For the afternoon program (team time trial), laundry, changing and shower facilities are available in Sportpark het Anker, Ankersweg in Buchten.

The participants must leave the washing and dressing facilities clean. Waste in the appropriate bins. Toilets are also available at changing facilities at both locations.

All garbage must be taken away by the teams at the Bike Park and the Sportpark het Anker car park.

Article 7

The team leaders meeting will take place at 09:00 at the Bike Park Sittard-Geleen in the boardroom (1st floor above the canteen). A maximum of 2 team leaders per team may participate in this meeting.

Article 8

While entering the Tom Dumoulin Bike Park (route 1) and on the course in Buchten (route 2), wearing a helmet is mandatory for all riders.

Article 9

The final list of participants is available from 09:00 in the permanence at the Bike park. The starting gun is at 10:00 am. The back numbers and frame plates and transponders must be properly attached.

Article 10

Team leaders may park their vehicles (maximum 2) in parking lot A of the Bike Park Sittard-Geleen. No vehicles may be parked in the courtyard.

Other supervisors and spectators must park in the other parking spaces (parking lot B) near the Tom Dumoulin Bike Park. The parking lot of the Fortuna stadium can also be used for a fee.

Article 11

It is strictly forbidden for the public to enter the inner area of the Bike Park. The public should stay behind the fences. Only riders, VIP guests, organization, judges and press are allowed to enter the area within the fences.

VIP guests, organization and press will be provided with a Keycord. This keycord entitles you to a place in the courtyard.

Article 12

A waste zone has been set up at the Bike Park in Sittard (route 1) and the course in Buchten (route 2). For all participants, only this waste zone may be used for disposing of water bottles and other waste

Article 13

At the race at the Bike Park (route 1) a rest area has been set up as well as a material station. A maximum of 2 people may be present per team.

Article 14

A maximum of 2 team leaders per team will be provided with a wristband during the team leaders meeting. This wristband gives 2 team leaders per team the opportunity to enter the supply or equipment zone in the inner area of the Bike Park.

It is expressly not permitted to pass on this wristband to other members of the team/other supervisors or parents.

Article 15

The participants and supervisors are obliged to follow all instructions of the jury, organization and other officials. Failure to do so will result in a starting ban or exclusion from the race. Unofficial persons riding in the caravan of followers is prohibited (team time trial)

Everyone rides with dipped high beam (concerns the team time trial). Drivers of vehicles participating in traffic outside the caravan must comply with the applicable traffic rules. Fines are for relevant drivers.

Article 16

All riders who are more than 1 lap behind in race 1 will be disqualified from the race and will therefore not be allowed to start in the team time trial.

Article 17

In the team time trial, the time of the 3rd rider is recorded.

Article 18

Before the start of the team time trial, the riders must present their bicycles for resistance control. For this they must report in time. <u>Time trial bikes are not allowed</u>,

Article 19

There is an entry zone. This one is near the starting podium

Article 20

The competition closes half an hour after the winner's arrival. Protests can be submitted to the president of the jury after the end of the competition. Submitting a protest is valid 30 minutes after the race (route 1) as well as for route 2.

Article 21

The organizers do not bear any responsibility for accidents or damage to third parties before, during and after the competition. Every rider who registers for the race agrees to this article

Article 22

The ceremony of the first 3 riders in the result (route 1) will take place on the podium Bike Park Sittard-Geleen.

The ceremony of the first 3 teams (team time trial) and the first 3 riders of the general classification will take place in the party tent in Buchten located on the Dorpsstraat near the finish.

Article 23

1 team leader's car will follow in the team time trial per team. This team leader's car must be provided with a sign with the name of the team. This sign is provided by the organization and must be handed in after the game in the permanence (party tent Buchten).

Article 24

The team leader's car that accompanies the team during the team time trial must keep a minimum distance of 30 meters from the team. It is forbidden to ride next to the team.

Article 25

The winner of the race (route 1) will start 1st with his team in the team time trial.

The number 2 of the race (route 2) will start 2nd with his teams etc etc.

The president of the jury will announce the order of start in the team time trial 1 hour after the finish of route 1. If several riders of 1 team (e.g. 1st and 2nd place) finish in route 1, nr 3 will start as 2nd team in the team time trial etc etc.

Article 26

After a team has crossed the finish line during the team time trial (route 2), the team will be met by an official of the organization. If the team has cycled fastest, the entire team will take place on the HOTSEAT immediately after the finish. The team stays there until a faster team finishes.

Article 27

The prize money is determined by the organization and the KNWU. The payment of the prize money takes place in the permanence Buchten (party tent Dorpsstraat Buchten) where the licenses are also returned and framing places can be handed in.
